2022 NON-RESIDENT VEHICLE STICKER

PROCEDURE

1. All Non-Resident sticker applications should be submitted online except for the members of the neighboring HOAs with a special arrangement to submit applications in bulk. Log-in to BFFHAI website at bffhaionline.com and follow the instructions.
2. For members of HOAs with a special arrangement to submit applications in bulk, use this form or download from BFFHAI website. Submit duly accomplished form to your association President. Attached photocopy of current LTO Official Receipt (OR) and Certificate of Registration (CR). When required, present original OR and CR for further verification.
3. Applicants with students in schools WITHIN BF Homes Subdivision must present photocopy of proof of enrollment for the current school year.
4. For company-owned car, submit an authorization to use from the company (in letterhead) together with the photocopy of the employee's company ID.
5. BFFHAI representative has been instructed to install the sticker on the upper right corner of the vehicle or front passenger side, intended to facilitate vehicle identification at the gates. All expired sticker(s) must be removed.
6. Non-resident stickers are limited to 2 per household.

RULES AND REGULATIONS

1. Elizalde gate is for the exclusive use of homeowners with **VALID 2022** resident stickers. Non-residents and all commercial vehicles **are NOT ALLOWED** to use this gate.
2. Use only appropriate lanes at the entrance and exit gates.
3. You are in a residential zone. **OBSERVE MAX. SPEED OF 40 KPH**, traffic signs and refrain from blowing your vehicle horn unnecessarily.
4. Observe the following parking rules:
 - A) Light private vehicles are allowed to park along the street fronting the homeowners / residents property. Double parking is prohibited. No counter-directional parking.
 - B) Service and Public Utility Vehicles are not allowed to park along the streets. Parking of these types of vehicle should be outside BF Homes premises or at designated parking areas approved by the Board of Directors of BFFHAI.
 - C) The main avenues, namely Aguirre, El Grande, Elizalde, Concha Cruz, Tropical and Palace Streets, have been declared as **NO PARKING** and **CLAMPING ZONES** at all times and vehicles found thereat in violation of the same shall be subject to penalties and / or removal of the stickers.
5. The vehicle's owner shall be liable and responsible for all acts of the driver while operating the vehicle inside BF Homes premises like violation of traffic rules, causing of accident, damages to person and property, etc.
6. BFFHAI reserves the right to **REMOVE/CONFISCATE** the sticker and/or **DENY ENTRY** in case of violation of BFFHAI's Traffic Rules and Regulations. Also, the use of the sticker may be suspended during the occurrence of any fortuitous event, public health condition, pandemic, national/local emergency and the like without any liability of BFFHAI.
7. In case of a breach or violation of BFFHAI Traffic Rules and Regulations, violator must immediately & voluntarily surrender his driver's license to the BFFHAI security guards.
8. The issuance of this sticker does not carry any acceptance of liability on the part of BFFHAI.
9. Lost/stolen or damaged stickers shall be replaced after paying a replacement fee of P150.00 and a **DULY NOTARIZED Affidavit of Loss**.
10. Overnight parking is not allowed inside the subdivision.

E. APPLICANT'S UNDERTAKING

I HEREBY BIND MYSELF TO FOLLOW ALL RULES AND REGULATION AS STATED ABOVE AND THAT UPON SALE OR DISPOSAL OF MY VEHICLE I COMMIT TO REMOVE THE VEHICLES STICKER AND RETURN THE SAME TO THE BFFHAI OFFICE. I HEREBY FURTHER BIND MYSELF TO THE FOLLOWING.

1. THAT THE STICKER IS NON-TRANSFERRABLE AND WILL BE PENALIZED WHEN TRANSFERRED.
2. THAT THE BFFHAI RESERVES THE RIGHT TO CONFISCATE THE STICKER FOR ANY VIOLATION OF THE RULES AND REGULATIONS OF BFFHAI, FOR ANY MISDECLARATION / MISREPRESENTATION IN THE APPLICATION FORM AND FOR THE MISUSE OF THE STICKER.
3. THAT A COPY OF THE BFFHAI OFFICIAL RECEIPT SHALL BE KEPT IN THE VEHICLE AT ALL TIMES.
4. THAT I UNDERSTAND AND AGREE THAT MY MOTOR VEHICLE MAY NOT BE ALLOWED ENTRY AT ANY OF THE GATES FROM 12 MIDNIGHT TO 5 AM DAILY.
5. I AM FULLY AWARE THAT BFFHAI RETAINS PERMANENT OWNERSHIP OF THE STICKER AND ISSUED TO APPLICANTS ONLY AS A PRIVILEGE OF PASSAGE; HENCE, BFFHAI HAS THE LEGAL RIGHT TO INITIATE AND FILE ANY, AND ALL CASES RELATIVE TO THE STICKER.

I CERTIFY THAT I HAVE READ ALL THE INFORMATION STATED HEREIN AND COMMIT TO FOLLOW BFFHAI RULES AND REGULATIONS. I FURTHER CERTIFY THAT ALL INFORMATION DECLARED HEREIN ARE TRUE AND CORRECT.
